Monitoring Report (Rickey)

- Monitoring should take place independently, rather than in groups
- Most properties may be monitored from the road
- Monitors should avoid walking in the woods alone
- Reduce contact, avoid visiting homes
- Bring and wear a mask
- Contact landowner in advance to let them know the date/time of monitoring visit

Whitewater Watershed Action Plan (Corey)

 Plan will be presented to Cornish Selectboard and Claremont City Council

- The watershed is the most valuable drinking water asset for Claremont
- Corey will email the document to Commission members
- Working group included members of the Claremont City Council and Public Works, Lionel Chute, Corey Fitch, and guest speakers
- Read the Plan

- Funds will come out of the operational budget

- Added railing, sand beach
- Needs mowing by the town, currently being done by volunteers
- Steep slope makes it difficult to mow the area
- Corey will send a letter to the selectboard
- Cindy will explore developing a 'Friends of the Cornish Swimming Hole' group and reach out to interested residents

Cornish Windsor Covered Bridge (Corey)

- Rip rap and center abutment repair pending
- Approved by DES
