# Cornish Conservation Commission (CCC) Minutes - 07-28-21

#### **DISCUSSION**

## 1. APPROVAL OF THE MINUTES OF THE JUNE 23, 2021 MEETING:

Corey asked if there was any discussion or change to be made to the draft minutes of the June 23, 2021 meeting as posted. Bill Gallagher said that it was he who seconded the motion to approve the May minutes. Jody Schubert motioned to approve the June minutes including this change. Bill Gallagher seconded the motion and the June minutes were approved unanimously.

Linda Leone asked the members if there were any comments on the new minutes' format. There were none.

### 5. RIGHT-TO-KNOW:

Several members had listened to the Right-To-Know presentation sponsored by the NH Association of Conservation Districts (LINK to NHACD Program on RSA 91-A Public Body) and discussed the CCC's adherence to the regulations. The CCC members are aware of requirements around emailing each other contemporaneously, what constitutes a meeting (LINK to Is It A Meeting Flow Chart) and are attentive to the need for transparency with the public.

Linda Leone said she would implement a modified process for communicating and gaining approval of minutes going forward:

- 1. She will produce a set of draft minutes within 5 days following a meeting; these will be posted on google docs and cornishnh.net;
- 2. Any immaterial edits (typos, grammatical errors, etc.) may be made by members online or by telling Linda until the following meeting;
- 3. Any substantive changes or discussion will take place at the next meeting, and the minutes will then be approved at that meeting as final;
- 4. The final minutes will be posted timely on google docs and cornishnh.net.

### **6. PLANNING BOARD MASTER PLAN UPDATE:**

Linda Leone (an alternate member of the Planning Board) noted that the Planning Board will begin its update of its Master Plan at its August 5 meeting. The Planning Board will start with a review of the VISION Section (LINK to 7-2021 VISION DRAFT) of the plan. The CCC may also be interested in the Community Survey of 2007, the data of which was used extensively in the Master Plan (LINK to 2007 Community Survey) (LINK to Survey Comments)

Cornish no longer has a seat at the table and may be missing critical participation in planning as well as discounted pricing for consultation. ACTION: Corey will email the RPC to discuss and report to the Board of Selectmen and the CCC.

## f) GLYPHOSATE LETTER

Corey Fitch read the 7/15/21 letter from the NH Dept. of Agriculture (LINK to 7-15-21 NH Dept of Ag Letter) in response to his letter re: use of glyphosate. The NH Dept. of Agriculture did not offer any chain of notification to Cornish nor respond specifically to any of the CCC's expressed concerns about invasive management practices by the NHDOT.

### h) MOWING AT SWIMMING HOLE IN THE FLAT:
