DISCUSSION

1. APPROVAL OF THE MINUTES OF THE JULY 28, 2021 MEETING:

3. LAND CONSERVATION IN CORNISH:

Corey reported having contacted The Forest Society about 200+ acres Cornish resident-owners are considering putting in a conservation easement. Corey offered the owners the Conservation Committee's financial assistance with administrative costs of the easement.

4. NEW HAMPSHIRE ASSOCIATION OF CONSERVATION COMMISSIONS (NHACC):

Their annual meeting will be held on 11/6/21 on Zoom and in person. Corey said that The Conservation Commission will cover any costs for its members who attend.

5. CONSERVATION COMMISSION BY-LAWS:

The members agreed to have further discussion at the next meeting as to whether the Board of Selectmen representative to the Conservation Committee should have voting power and to clarify and finalize the definition of this role: alternate member, ex-officio member, or a non-voting representative from the Board of Selectmen.

6. LAND MONITORING IN CORNISH:

Jody Schubert noted that she will go to the Town Offices to read the original monitoring file for White Swan Farm; and will follow up with monitoring. Linda and Corey would like to be involved. Reyer will update about Meyette's land in the near future.

7. CONSERVATION COMMISSION BOXES AND OCTOBER CONSERVATION NOTES:

Boxes: Bob will add notice of dates of different hunting season dates to the boxes, and Monica will send Bob an article on fall blooming plants along our roadsides.

Notes: Cindy's fall article on trees and climate change will include information on what makes leaves take on different colors and a note about milkweed pod collection activities sponsored by the University of NH.

- NRI documents: Corey will follow up on NRI documents/updates with Jody's assistance.

- Education Committee: Jody reported that general activity Conservation Boxes, the Conservation Notes, financial support to 4 Winds program at the Cornish School (which is active again this school year) and Corey and Jody are volunteers for this year's program, and as a result of 4 Winds activities there will be heightened use of the CREA property. A longer term goal of the CCC is to meet with the Principal and science teachers to see how we might generate more educational activities or events between CCC and the students. Jody will coordinate a meeting of the Committee with Bob and Cindy.

- Glyphosate: has been banned in parts of the US. New book out by Chelsea Green could be a helpful resource.
- Award for Caroline Storrs: Corey reported that a garden-related Harry Bliss cartoon has been selected. He will follow up, using the Junction Frame Shop in White River Junction, VT.
