Said library building and library to be maintained by said town when so constructed, and raise money therefor.

13. To see what action the Town will take regarding publishing the town history, and if thought best, to raise

money therefor.

14. To see if the Town will vote to adopt the Australian voting system at their March meetings.

- 15. To see if the Town will vote to return the highway agent system and elect agents therefor.
- 16. To see if the Town will vote to instruct the Selectmen to procure a road machine, and raise money therefor.
- 17. To hear the reports of Officers, Agents, Auditors and Committees heretofore chosen, and pass any vote in relation thereto.
- 18. To transact any other business that may legally come before this meeting.
