 - a. - 4. NRI Update: Maps Workshop/Corey & Glenn. Corey referenced his dialogue with Austin Foote, a revised scope, a draft contract, and CCC's work-in-progress outline of NRI maps. The CCC reviewed and discussed the documents in detail, updating the CCC work-in-progress NRI map outline with changes to be carried through to the scope. Corey will also review the contract with the Select Board before it is finalized, deferring to their choice relative to whether they or he will sign it.
